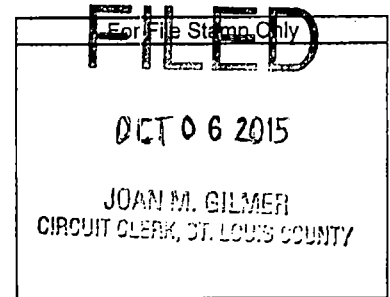

Order and Judgment

Pending before the court is the verified petition of Nicholas A. Matthews for Appointment of Successor Trustee of the Dorothy Ann Glover and Julian Frank Glover Revocable Living Trust dated March 2, 2001 (hereinafter "the trust").

The court takes judicial notice of its file and the record of proceedings in this matter, including, but not limited to the verified petition, all exhibits or attachments thereto, and all other documents, memoranda, or other writings filed in support thereof. In rendering this Order and Judgment, this court has expressly relied upon the aforementioned record of proceedings and its continuing accuracy and validity. This court has further relied upon evidence adduced at the evidentiary hearing conducted on Oct. 6, 2015.

Based upon the facts contained in the record of this proceeding noticed above the court finds as follows:

1. The court has jurisdiction over this trust under Section 456.2-202.1, RSMo.
2. Venue for this matter is proper in this court under Section 456.2-204.1(2), RSMo.
3. Dorothy Ann Glover died on March 4, 2004. Julian Frank Glover died on February 24, 2015.
4. Under the terms of the trust, David Christopher Emanuel was named successor trustee. David Christopher Emanuel died on Nov. 19, 2014. The trust makes no other provision for appointment of a successor trustee.
5. A vacancy in the trusteeship of the trust has occurred and the trusteeship is required to be filled.
6. Nicholas A. Matthews is the child of Julian Frank Glover and is a qualified beneficiary of the trust. He is before the court asking to be appointed Successor Trustee.
7. LaCharles Whittaker is the adult son of David Christopher Emanuel and is a qualified beneficiary of the trust. He has consented to appointment of Nicholas A. Matthews as Successor Trustee.
8. Daija M. Emanuel is the daughter of David Christopher Emanuel and is a minor. She is a qualified beneficiary of the trust. Delicia Emanuel is the mother of Daija M. Emanuel and has consented to the appointment of Nicholas A. Matthews as Successor Trustee.
9. William Louis Pearson II is the son of Dorothy Ann Glover and is a qualified beneficiary of the trust. He has consented to appointment of Nicholas A. Matthews as Successor Trustee.

10. Markeeta M. Williams is the daughter of Dorothy Ann Glover and is a qualified beneficiary of the trust. She has not consented to appointment of Nicholas A. Matthews as Successor Trustee.


11. The vacancy in the trusteeship must be filled in order to properly administer the trust and to proceed with work necessary to close the trust estate.

12. The court has authority under Section 456.7-704.3, RSMo to appoint a successor trustee.

13. Based upon the facts disclosed in the record of proceedings and evidence adduced, the relief sought by petitioner in his petition for appointment as successor trustee is appropriate and should be granted.

WHEREFORE, it is ORDERED, ADJUDGED, and DECREED that pursuant to Section 456.7-704.3, RSMo, Nicholas A. Matthews is appointed as Successor Trustee of the Dorothy Ann Glover and Julian Frank Glover Revocable Living Trust dated March 2, 2001.
